PLEASE NOTE: Tuition for the 2026/27 Year-Round Program DOES NOT include the \$300 per show Performance Fee or the optional \$350 per show Volunteer Buy-out Fee; both are in addition to the tuition fees.

For the Pre-Ballet, Jr Division 1, and Jr Division 2 levels, performances are optional yet highly encouraged. For the Junior Boys, Jr Division 3 and up, performances are mandatory.

INTERNATIONAL STUDENTS: An additional International Administrative Fee of \$800 will be incurred by any student under the age of 18 who is not a United States resident at the time of their participation in our program. This fee will be applied toward the cost of program assistance provided to the student by CBSF and the exchange program liaison.

DUE DATES

- **Registration:** Registration and \$500 non-refundable deposit are due **July 15, 2026**. The deposit is applied toward the total Year-Round Program tuition.
- **Balance:** The outstanding tuition balance after paying the registration deposit can be paid either in full by September 1, 2026, or in installments per the payment schedule as listed above.
- **Additional Fees:**

Performance-related fees and any Competition-related fees will be due before the start of the first rehearsal.

Spring Show: **February 15, 2027**

- **Summer Intensives Tuition**
 - A non-refundable deposit of \$500 for the 2027 Summer Intensive is due **January 15, 2027**. The deposit is applied toward the total Summer Intensive tuition.
 - Tuition balances must be paid in full by **May 8, 2027**. No exceptions will be made to this policy.

PAYMENTS

- Payment plans may be established at the **time of registration**.
- All tuition, session options and performance fees (including for payment plans) are to be paid through the Class Manager portal.
- Payments can be made either by credit card (3.5% fee) or Direct Debit, payable through Class Manager. **Payments made by check or cash must be pre-approved by the administrative office.**
- **LATE PAYMENTS** (those not made within the 5-day grace period) will result in a \$25 per week surcharge.

REFUNDS

- There will be no tuition refunds or proration for missed classes.
- There will be no tuition refunds or proration for school withdrawal or dismissal.
- There will be no tuition refunds or proration for payments for any portion of the Summer Intensives
